EXECUTIVE DIRECTOR REPORT

It has been my honor and privilege to serve CPA as Executive Director since May 7, 2021. During the course of last year, all CPA service bodies underwent major leadership transitions. From the Board, to the General Service Virtual Office (GSVO), to the General Advisory Council (GAC), and Intergroups, new trusted servants stepped forward and found their footing. Of course, there were stumbles along the way, but it has been made clear to me time and time again that Higher Power continues to guide, care for, and support CPA and that the group conscience process best facilitates thriving and exciting teams. Our common welfare does indeed depend upon unity, and there is nothing we cannot do together. Go, Team!

I, as Executive Director, oversee the GSVO and am directly responsible to the CPA Board of Trustees. The GSVO is composed of the bookkeeper; literature management, which includes the CPA Store and publishing arm; the Meeting Liaison; the Literature Committee; History/Archives; and the website and all social media.

It was a joy to welcome our new CPA Store Manager, Sherry, and our new Literature Committee Chair, Mica, to the GSVO team. I am excited to institute the GSVO all-staff quarterly meetings in 2022.

Even during the challenging transition year, the GSVO continued to handle the dayto-day operations, thereby fulfilling CPA's primary purpose of carrying its message of hope. Thanks to our Concepts' spiritual principle of delegated authority and to our dedicated, hardworking volunteers, our bills get paid, inquiries are responded to in a timely manner, folks can easily find CPA information, and new literature is in the works.

The GSVO also exists to implement decisions of the WSC. The new Conference Approved Literature (CAL) from the 2021 WSC is available and printable on the CPA website. For the sake of fiscal prudence and the lack of demand due to the pandemic, color printing and making these items available for purchase in the CPA Store remains on hold. At this time in our CPA history, literature is not a source of revenue. It is a service expense.

Your 7th Tradition contributions, and your contributions alone, are what fund CPA services and allow the GSVO to run. I thank you for your ongoing support.

I would like to take a moment to thank by name your GSVO staff: Alisa, Catherine, Laurelle, Mica, Sherry, and Terry M. You are amazingly gracious and generous volunteers, and CPA would suffer without you!

If you would like to join our GSVO team, consider the open position of History/ Archives. It is a simple and straightforward position that asks you to record CPA events and occurrences once a quarter (only four times a year). No experience is needed as you and I will work together to get you started. Please email me at serviceoffice@ chronicpainanonymous.org and request an application.

Please see the WSC Summary Report in a couple of months for my full report of all the accomplishments in 2021 – there are a lot. I do, however, wish to share with you, in true CPA fashion, the accomplishment I am most proud of in 2021: after three years of intensive CPA service, I took a two-week vacation!

VOTING PROTOCOL

Billy - Welcome, Delegates.

Thank you in advance for your attention regarding our WSC voting protocol.

Warranty Four states "that it reach all important decisions by discussion, vote, and whenever possible, substantial unanimity."

When possible, issues are discussed until there is certainty that all minority opinions have been heard and most people can support the decision. Usually a two-thirds acceptance means a motion passes, but this ratio is decided at the Conference each year.

Substantial unanimity is the calculation of two-thirds of total members voting on any given item – not the total of registered delegates. Delegates may need to leave during the Conference for self-care or other reasons. The secretary must be notified prior to any change of delegate for a voting session. We are guided to consider all viewpoints and strive for substantial unanimity. Differences can be discussed, and a solution can be found. We listen to others and have permission to disagree, and we abide by the group vote.

Mica – Hey, wait a second. I have a few questions. I have read through the voting protocol a few times and the more you guys explain it to me, the more it makes sense. Can you explain substantial unanimity in a different way?

Billy – Substantial unanimity is when we have at least two-thirds of the fellowship championing what we are voting on. CPA does not aim for just 51% as in the simple majority vote. We strive for greater backing from the fellowship.

Mica – That helps, Billy. Thanks!

Billy – My pleasure. Moving on... We are grateful for our trusted servants Jes, Letha, and Terry M., who graciously volunteered to relinquish their votes to meet quorum and tally votes by reading the roll call, recording individual votes, and calculating substantial unanimity for each vote.

Mica – Wait a minute, what does quorum mean again, and why are some people giving up their votes?


Terry M. – The CPA Service Handbook states in the description section of Concept 4: *There is balance in that the Service Board of Trustees and service workers together makeup no more than one-third of the voting at the WSC.* So, some members of the WSC Planning Committee volunteered to surrender their votes. This is so the fellowship has the majority voice during the Conference. Our Charter states: A quorum consists of two-thirds of the delegates registered for the WSC. So please note that if, for some reason, 1/3 of all delegates left the conference, we would not meet quorum and would have to end the WSC.

Mica – Thank you for explaining that. I have another question. When you abstain, how does that affect the vote count?

Terry M. – Abstentions do not count in tallying the vote negatively or positively; when members abstain, they are in effect attending only to contribute to a quorum. This means we need 2/3 bodies of all attendees be present to vote. Abstentions still count toward substantial unanimity, and if the two-thirds are not met, the motion does not pass. Decimal points are rounded to the closest whole number.


Mica – Doesn't an abstention still count as a no vote then?

Jes – I think I can help here. It is important that every delegate present for a vote understands their responsibility to that vote. You are counted whether you vote yes or no or abstain.

Enough abstentions might keep something from passing; however, that means that the item up for vote didn't have enough delegates championing the cause.



It wouldn't be an accurate representation of the fellowship's support of something if it passed with only three votes because everyone else abstained. Let me show you...

Mica – I think that visual will really help it stick this time. One more thing. Can you remind me of the importance of the minority opinion?

Letha – I can help with that. **Concept Five** honors the Right of Appeal/Minority Opinion. Any delegate may state their minority opinion, which ensures all views are honored and considered.

Once the minority opinion is shared, the chair asks if anyone who voted in accordance with the popular vote wishes to change their vote. If no one does, we move on with the agenda. If even just one person does wish to change their vote, the chair will ask for a motion and a second to retake the vote. Keep in mind that if no one seconds the revote motion, the motion dies and we move on with the agenda. If there is a second to taking a revote, the voting process begins again by the chair calling for discussion time.

And please remember that any member is welcome to request a moment of silence or the recitation of the Serenity Prayer before any vote, as we seek Higher Power's will for CPA, not our own.

Mica – Thank you all for explaining all this...again.

Terry M. – Thank you, Billy, and our WSC Planning Committee Team.

At this time, total voting participants are 42. A passing vote is 29 persons in favor. This will be recalculated prior to each item voted upon.

I would like to take a vote right now. Do we have a motion that 2/3 of participants voting qualify as a "substantial unanimity"? YES. And a second? YES. Thank you. MOTION: PASSES.

Thank you for allowing me to be of service and for your delegate service in support of our primary purpose.

PROPOSAL FOR FELLOWSHIP APPROVAL

"Proposal to change 'men and women' to 'people' in CAL"

CPA strives to be a fellowship of inclusivity, and this proposal follows that principle. As not all our fellowship members (past, present, and future) identify as a "man" or a "woman," we propose that our literature be updated to reflect this reality. This is a three-part proposal to replace the term "men and women" with "people" in CPA's Conference Approved Literature (CAL).

PROPOSAL PART A

This is a proposal to change "men and women" to "people" in the Preamble. The Preamble is located in the Preface of *Stories of Hope* and on the chronicpainanonymous. org website located under Resources, Meeting Materials, Materials for Meetings, CPA Preamble. The website version would change as soon as possible. The Preamble in *Stories of Hope* would change when a 2nd edition of the book is printed, and so on.

A "yes" vote also means any new Conference Approved Literature that chooses to include the Preamble would be printed with this updated version of the Preamble.

CPA Preamble

CPA is a fellowship of people who share their experience, strength, and hope with each other, so that they may solve their common problem and help others to recover from the disabling effects of chronic pain and chronic illness. We believe that changing attitudes can aid recovery.

The only requirement for membership is a desire to recover from the emotional and spiritual debilitation of chronic pain or chronic illness. There are no dues or fees for CPA membership. We are self-supporting through our own contributions. CPA is not allied with any sect, denomination, politics, organization, or institution; does not wish to engage in any controversy; and, neither endorses nor opposes any causes.

Our primary purpose is to live our lives to the fullest by minimizing the effects of chronic pain and chronic illness in our lives and helping others to do the same. We do this by practicing the Twelve Steps, and by welcoming and giving comfort and understanding to each other.

- Motion approved/Motion seconded

Discussion – PRO:

- AA initially voted on this the exact wording.
- Keep it simple/Like it simple.

- Like that it not only addresses gender, it takes the age issue out/Inclusive for teens.
- The "We" of the program lends itself to people.
- Love the inclusivity of the proposal.
- Thanks to the Literature Committee and all their hard work.
- Some people have Higher Power that are gender fluid, this is very important to them.
- This change represents to our current and future members that we want to be inclusive.
- Takes nothing away from anyone/Gives so much hope to many now and in the future.

Discussion - CON:

- Wish we did not have to wait a year to vote.
- Strong beliefs in God, who created us, gave us genders at birth.

VOTE = FOR: 41 AGAINST: 0 ABSTAIN: 1 MOTION: PASSES

PROPOSAL PART B:

This is a proposal to change "men and women" to "people" in the "All About Service" brochure and in sections of *Recipe for Recovery* and *Stories of Hope*. In the "All About Service" brochure, this change would happen as soon as possible. In the books, these changes would take place when a 2nd edition of each book is printed, and so on.

A "yes" vote would also mean that going forward, the word "people" would be used in new Conference Approved Literature whenever referring to the members of the fellowship as a whole.

A "yes" vote would be approving the change of "men and women" to "people" in the following places (we are not looking for feedback on any other aspects of these texts):

Brochures:

• "All About Service" – introduction

Chronic Pain Anonymous (CPA) is a worldwide fellowship of people from all walks of life who live with chronic pain and chronic illness. Members come together to support each other and learn how to find serenity and a meaningful life while living with the disabling effects of their physical health conditions.

Recipe for Recovery:

• "About Step Study," "A Note on How the Book is Organized" – 1st paragraph

Each chapter will have a list of "Ingredients," the psychological, emotional, and spiritual aspects that best go into working that Step; a "Description" of what the Step will help us learn and discover and lead us to on this journey; and "Directions," which are ways

that members have worked on the Step. Feel free to use these Directions exactly as suggested or as jumping-off points and inspiration for you and your sponsor. At the end of each Directions section, you'll find "Working the Step," a list of questions to help you delve deeper and explore all facets of that Step. The "What It Looks Like" section ends each chapter. These are personal experiences, written by the people of CPA, who describe how they applied a Step when living with chronic pain and chronic illness. They illustrate what the Step looks like when it is applied in one's daily life.

• "Conclusion," – 3rd paragraph

With the guidance of our Higher Power, this is a program of new patterns of perception and being—of transformed thoughts and actions. It makes possible what we thought was not: to see ourselves as people deserving of love and kindness and happiness, living expansive, meaningful lives. It is a recipe for renewal, for joy, contentment, and belief in ourselves and others, which many of us had thought was lost forever.

• "Stories of CPA Recovery," – 1st paragraph

Chronic Pain Anonymous was created in 2004. Since then, many people have benefited from the tools and principles of our program based on the Steps described in this book. In the stories that follow, the people of CPA share their personal journeys on the path to recovery from the hardships of chronic pain and chronic illness. They describe how this simple spiritual program improved their lives, showing them the way to live "peacefully, joyfully and comfortably with ourselves, and others."

- Motion approved/Motion seconded

Discussion – PRO:

- It is inclusive no matter what their background Great change.
- Conveys a message that CPA is an open and affirming community regarding everything.
- Plenty of peer-reviewed scientific studies about the gender spectrum.
- Thrilled that we have a chance to support the newcomer by being more inclusive.
- Famous quote "We the people to form a more perfect union."
- "People" does not take away male or female from the person who identifies as such.
- This is loving, deserving of love and dignity.
- Would this be the same if it were originally written "people"?
- Traditionally we see "men" written first; "people" takes this out of the equation.
- This is just about growing.

Discussion – CON:

• Strong beliefs in God, who created us, gave us genders at birth.

VOTE = FOR: 41 AGAINST: 0 ABSTAIN: 1 MOTION: PASSES

PROPOSAL PART C:

This is a proposal to change "men and women" to "people" in the personal stories in *Recipe for Recovery* and *Stories of Hope*. These changes would take place when a 2nd edition of each book is printed, and so on.

A "yes" vote would be approving the change of "men and women" to "people" in the following places (we are not looking for feedback on any other aspects of these texts):

Recipe for Recovery:

• Suffering is a State of Mind" – 14th paragraph

Chronic pain does not discriminate; in our meeting, we have people, young and old, and a diversity of racial, ethnic, and socioeconomic statuses. Within this fellowship, we are all able to guide and support each other to live a fulfilling and serene life, despite having chronic pain and illness. We do this by embracing the CPA principles through the literature and by working the Steps.

Stories of Hope:

• "Courage" section, John Coltrane quote – 4th paragraph

Today while at the mechanic's garage I wheeled my chair outside where some people were taking a smoke break. Our conversation came around to why I was in a wheelchair, as it usually does. How awful it seemed in their minds. I told them it wasn't that bad if one were able to accept reality. We can't control the cards we are dealt in life, but we can control how we respond. Well, our group of smokers and nonsmokers started to grow as the conversation moved into being responsible for our lives and accountable to ourselves and others. I don't think many of these people often engaged in this type of conversation. Before I started talking there was a lot of complaining. After I got involved, that mood changed . . . it was a lot of fun!

- Motion approved/Motion seconded

Discussion – PRO:

- It has always been my understanding that when stories are submitted, they will be edited.
- The important thing is that these stories are given to the fellowship, it is intended to represent the entire fellowship and is not intended for one person.
- It is what we put forth as our values, views, what is means to work for the fellowship.
- Literature Committee tries its best to edit stories as little as possible.
- Stories reflect everyone and are more universal.
- Collecting 400 essays gets turned into 366-page book takes heavy editing. Once it is given to CPA, CPA owns it.
- All literature should have the same words (people vs. men and women).

Discussion – CON:

- Direct quote from John Coltrane not appropriate to change a direct quote. (Changes will be in the body, not direct quote.)
- I would have wanted to be in the know if it was directly from me. People should be told if their story is being changed.
- The fact that it is a personal story and are frequently changed. Sometimes they get to see it, sometimes they don't.
- This changes the intent of the paragraph, suggestion for the future the committee comes up with better change as to not change the intent.
- The proposal says that it is not open for discussion, our group did not discuss. (Proposal was misread.)
- Stories may have specifics; this proposal is for these two stories. I don't think someone's stories should be changed.
- Once they are published, we really need to leave them alone. Why were these two put together, and why not each as their own vote?
- Very against changing stories once they are published.
- Our primary purpose is to carry the word to the newcomer, be inclusive. If my words were changed maybe that's not ideal. Small details are way less important, times are changing, there are so many more ways of speaking to gender.

VOTE = FOR: 31 AGAINST: 9 ABSTAIN: 2 MOTION: PASSES

FINANCIAL

Accomplishments in the past year:

We are thrilled to have approved the formation of a Finance Committee. This will provide us with group participation for the prospects of financial expansion and budgeting for 2022.

End-of-year financial summary: Cash on Hand: \$14,330

Income and expense: Total Income: \$15,140

- Sales of books and literature: \$3,287
- Donations from individuals: **\$9,844**
- Donations from groups: **\$1,387**

Total Expenses: \$10,700

- Accounting and bookkeeping: **\$2,970**
- Books and literature: **\$5,014**
- Other miscellaneous expenses mostly operations such as postage, office supplies, printing of brochures, website, phone, and bank fees

The full financial statement will be available at the end of the WSC summary report.

The difference between our income and expenses does not allow for a prudent reserve, which is not only a necessity but a priority as well. With this goal, we will not only build a safety net but will provide funds for projects that are in the works and future projects as well.

Current projects:

- New budget format to improve financial foresight and planning
- Improve and grow our 7th Tradition culture over the next years so that we can grow and meet the needs of current and future members

On that note, I would like to remind all of us that CPA is funded solely by our members' donations. As members, we benefit from a multitude of support and services that come at no direct cost to us. Most times, we are not physically able to pass a basket for our donations. I learned that the duties of this position were to receive the orders from Blue Host, fulfill said orders, and create two copies of the invoice (one for the recipient and one for the files). At this time, the package would be weighed to figure out the most economical way to ship it. Then I would go to the post office, mail the order, and obtain a receipt for our records. Lastly, the order is marked completed on Blue Host.

From January 2021 to the end of December 2021, the Store fulfilled twenty-six orders. The Store also purchased a postage scale from Amazon. Additionally, there was a cost incurred when the Store's materials were mailed to me. The only other expenses incurred were postage.

I am most appreciative of those who selected me for this position. I love doing service work, and this position makes me happy. If I had to make an improvement, it would be to have more orders to complete.

WEBMASTER

Accomplishments in the past year:

The Web Design Team is very grateful for another productive and exciting year. We had many changes to the team this year and still have seen our work improve the website as a whole, to ensure our members have what they need on a daily basis.

2021 saw a change in our Executive Director, so our team went through a transition of members. During this transition, we used our new literature, *Our Common Welfare*, to help us ensure our work was being done in line with our traditions and our service structure flow chart. We saw ourselves interacting with and collaborating with other committees within CPA more often, which means more members' voices were being heard regularly when it comes to their experience, strength, and hope in relation to using the website.

As always, this team's goal is to ensure the website is accurate and functioning. Most of our work is updating meeting information and adding any special events to the calendar. We also regularly use a "test" website to update software, making sure the updates play nice with the rest of the website. Once tests are run successfully, we then update the actual website that all of you use. This ensures if an update breaks the website, members themselves don't have to deal with the website being down.

Our main focus on improvements this year was making sure both new and current members have easy access to information about CPA, including our history, how we are structured, and access to documents. The menu was tweaked in a couple ways to make it easier for members to find what they are looking for. The "About Us" page was given its own link in the "About CPA" menu, called "CPA Info" instead of being a menu header. The "Find a Meeting" menu header was changed to "Meetings," and a new "Find a Meeting" page was created to help explain our Intergroups and calendar. Our "Books" page was split into two separate pages, CAL and non-CAL literature. Finally, our World Service Conference section was combined into one page. We also added the "Press/Media" page to the footer to help non-members find the contacts they are looking for and added contact information to the "Press/Media" page. We hope these changes make the flow of the website easier to understand and that information is easier to find.

Time zones have always been a tricky part of displaying meeting information, and we reviewed and improved our time zones information across both the meeting pages and the meeting calendar to help clear up any confusion. We removed the GMT time zone, since it does not observe daylight savings time, and we also clarified Eastern Time (EST to ET). There is also a section in the new "Find a Meeting" page that explains how to convert meeting times to time zones around the world.

We have been working on the Meeting Calendar itself for two years now, and 2021 saw the completion of these improvements. We tweaked the settings of the calendar to ensure it is loading for members as fast as possible, and we also added a new section, "Special Events," so that things like workshops have their own category. We are very excited about the difference between what the calendar looked like in January 2020 compared to what it looks like and performs like now, and we hope these improvements help everyone find and join their meetings with greater ease.

Last, but definitely not least, we improved our security to both the website itself and the server it lives on. Members with access to these, including those with service email accounts, were guided in creating secure passwords and were advised on how to safely store them. This ensures that we are not an easy target for hackers trying to make a buck.

We want to thank CPA members for their input and support this past year as we continue to make sure the website is what you deserve. As chair, I have cherished every conversation with each member this past year, as doing this service helps me in ways I could never have fathomed before I started my recovery journey. May 2022 bring as many blessings to both my team and CPA as a whole.

Additional information:

2021 was a leaner year in terms of projects and improvements, and we expect 2022 to be more of a year that our "wouldn't that be nice list" gets tackled a bit more, with help from other committees and CPA members. The first thing we would like to tackle is to continue improving the flow of the website, which means a hard look at our entire site map and ways it can be improved by rearranging pages and the information on those pages. We would also love to finish our newcomer page, so that new and prospective members have a one-stop shop for all their questions.

Other items on our wish list include improving where we show up on Google and other search engines when prospective members are looking for support, relaunching analytics so that we can see how our website is being used, rewriting our team's how-to document so that our next chair has all the information they need in a wellorganized format, and possibly creating an FAQ page for both new and current members alike. As always, we will listen to Higher Power and be guided to where we are needed most!

PROFESSIONAL ADVOCACY

2021 was a year of change, and there seemed to be a feeling of "pause" – I believe for all of us.

Here are some highlights from the Professional Advocacy Committee:

- Anastasia presented a workshop in the beginning of the year, and CPA has three slides as well as the Public Service Announcement on isolation. Despite resigning from the Board at the end of 2021, Anastasia plans on continuing to keep the information in her PowerPoint presentation.
- Both Anastasia and Bruce made appearances on the very popular Facebook podcast hosted by Lauren Zalewski, a former Board member. The program is called Gratefully Living the Chronic Life, and Anastasia and Bruce each discussed CPA as part of their appearances.
- Anastasia promoted CPA through her website, Blogged, and by a mass email to Georgia Therapy Network and Southeastern PLA, which is an information group for treatment centers and therapists.
- In addition, Anastasia shared information about CPA on Atlanta-area Facebook pages.
- Bruce continued to Tweet about CPA meetings and to inform professionals in Connecticut, New York, and Pennsylvania about the benefits of CPA.
- Both Anastasia and Bruce have CPA links on their websites.
